

Canine Connection Boarding Agreement

This is an Agreement between Canine Club LLC d/b/a Canine Connection (hereinafter called "CC") and the pet owner whose signature appears below (hereinafter called "Owner"). By signing this Agreement and boarding his/her pet(s) at CC, Owner agrees to the following:

1. Owner agrees to pay the rate for boarding in effect on the date pet is checked into CC for boarding.
2. Owner agrees to pay all costs and charges for special services requested, and all necessary veterinary costs for the pet during the time said pet is in the care of CC.
3. Owner agrees that the pet shall not leave CC until all charges are paid to CC by Owner.
4. Owner certifies to the accuracy of all information given to CC about said pet, that CC's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200 per pet boarded.
5. Owner agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of CC.
6. Owner specifically represents that he/she is the sole owner of the pet.
7. Owner specifically represents to CC that the pet has not been exposed to rabies, distemper, parvo virus, feline leukemia or other contagious diseases within thirty days before boarding.
8. Owner specifically represents that the pet has up-to-date vaccinations. Owner must submit written verification that his/her dog(s) has current DHLPP, Rabies and Kennel Cough vaccinations. *Specifically, the vaccines required are Distemper, Hepatitis, Leptospirosis, Parainfluenza, Parvovirus, Rabies, and Bordetella. It is Owner's responsibility to provide on-going verification of current vaccinations. Owner will be charged a "special needs fee" if it is necessary for CC's staff to secure verification.*
9. All pets must be in good health. Owner will need to certify that his/her pet is in good health and have been free from any condition that could potentially jeopardize other pets. *Pets who have been ill with a communicable condition in the last 30 days will require veterinarian certification of health to be admitted or readmitted.* If, at any time during care, a pet is noticed to have fleas or ticks, treatment will be applied and charged to the Owner at the minimum rate of \$30.00. All pets will be examined for signs of fleas and ticks at check in and will not be admitted if fleas or signs of fleas or ticks are noticed.
10. Quick release collars with nametags are required for dogs. Retractable leashes are not allowed.
11. All food brought to CC must be stored in an airtight/rodent proof container. Plastic baggies or opened dog food bags are not acceptable. Food for boarding must be divided into separate meals. If this is not done, CC will do this and charge Owner a "special needs fee." This is to ensure proper amounts per meal.
12. Reservations are required. **Cancelled not made by 6:30 p.m. one business day prior to the scheduled boarding will be charged half the total scheduled boarding amount (excluding holidays, where the full amount will be charged).**

13. All charges incurred by Owner shall be payable upon pick-up of pet. CC shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding the pet at CC. If Owner does not pick up the pet within fifteen (15) calendar days after the day the pet was due to be picked up, the pet shall be deemed to be abandoned, and necessary steps will be taken to turn the pet over to the proper authorities.
14. If the pet becomes ill or if the state of the pet's health otherwise requires professional attention, CC, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the pet, all expenses to be paid by Owner.
15. All CC Rules and Regulations are subject to change at any time without notification.
